Health Protocols for Arrival to Sri Lanka

Step 01 – Confirm your Arrival and Departure dates with valid flight schedule.

Step 02 – Send your fully vaccination certificate and passport copies to Lotus Villa. (Only fully vaccinated guests will be accepted with effective from 20th January 2022)

Step 03 – Apply VISA via <http://eta.gov.lk/slvisa/>. Once you done the relevant VISA payment, you will receive ETA confirmation. All VISAS must be applied online.

Step 04 – Obtain official booking confirmation and stay invoice from Lotus Villa. Pay mandatory covid 19 local Insurance charges using below online portal. Please note that PCR tests are not mandatory after arrival in Sri Lanka or when departing from Sri Lanka. But kindly check with your departure airline and landing country/airport requirement for PCR test.

- Covid 19 local Insurance coverage charge – **USD 12.00 per person**

All travelers arriving to Sri Lanka should obtain mandatory covid 19 local Insurance coverage using below online portal.

- **PCR tests – Fully vaccinated travelers – Exit PCR test** - If your final dose of the vaccination process completed before two weeks of the arrival date to Sri Lanka, you will be considered as vaccinated guest.
 - No mandatory PCR test on arrival
 - During the stay, if develop covid 19 symptoms should conduct covid 19 test
 - Exit PCR to be arranged as per the requirement from country of origin, airline requirement
- PCR test charges – **Euro 35.00 per test + Laboratory Charges (Around Euro 25.00)**

Step 05 – Settle final stay invoice, online Insurance payment to obtain covid 19 coverage before arrival to Lotus Villa.

Step 06

02 years and above travelers should carry a negative covid 19 PCR test report in English language done within 72 hrs prior to boarding to the flight

Travelers should bring covid 19 English vaccination certificate (hard copy) or QR code issued to them.

Step 07 – All the travelers arriving in Sri Lanka via airports shall mandatorily fill the **online Health Declaration Form** individually and upload the relevant documents (Vaccination record, predeparture Covid-19 negative test report, Data page of the passport etc.) prior to boarding. They should arrive with the QR code (in mobile phone/hard copy) issued to them. (This direction will come into effect from 01.01.2022)

Step 08 – Re-check relevant documents prior to boarding to the flight and at the airport checking.

Prior to Boarding:

1. Have a valid tourist VISA.
2. Have negative PCR report (English) taken within 72 hours before the flight / negative Rapid Antigen Report within 48 hours before the flight
3. Valid passport and return Air ticket.
4. Completed Health Declaration Form (online)
5. Covid 19 Insurance confirmation from online portal.

At the Airport Checking:

1. Negative Covid 19 PCR test report (English) taken within 72 hours before the flight / negative Rapid Antigen Report within 48 hours before the flight
2. Original copy of fully vaccination certificate. (English) – Hard copy or QR code in mobile.
